## APPLICATION FOR CONCESSION STANDS, CRAFT BOOTHS & DISPLAYS

Thank you for your interest in the 19<sup>th</sup> Annual Blossburg State Coal Festival. We look forward to your participation.

The Dates of the Coal Festival are May 25-28, 2011. The hours will be May 25, 26, 27: 6-11 pm and May 28 (Saturday): Noon to 11 pm.

**Booths:** 12'x12', space will be allocated on a first come, first serve basis. All vendors must provide their own table, tent, and display structures. Booths must be setup by 5 pm Wednesday, Thursday, and Friday. Booths must be setup by 11 am on Saturday.

**Electric:** 110 /15s available at no charge. 220 volt is available for an additional fee.

**Fees:** \$100 for all 4 days or \$50 per day. All fees must be paid before setup begins. No early tear downs. You are expected to participate in the entire day's festivities.

**Vehicles:** vehicles must be removed from the area by the opening of the day's festivities. Due to liability issues, no loading or unloading will be allowed during festival hours – **No Exceptions.**

**Cleanup:** You are responsible for cleaning the area around your booth continuously during the entire event. At the end of the Festival, all refuse must be removed. Dumpsters will be provided for trash disposal.

**Animals/Pets:** Absolutely no animals except guide animals will be allowed on the Festival grounds.

**For-Profit Food Vendors:** For-Profit Food Vendors must have a current PA Dept. of Agriculture Certification.

By participating in the Blossburg State Coal Festival, you agree to abide by the rules set forth by the Coal Festival Committee. The Coal Festival Committee reserves the right to reject **any** vendor application or contract.

All booths, displays, stands, etc. held in conjunction with the Blossburg State Coal Festival must be approved **in advance** by the Coal Festival Committee. Every individual, business, or organization planning to participate in the Blossburg State Coal Festival must complete this application. The committee reserves the right to request removal of any item(s) from the Festival grounds.
